8.0 PROPERTY REPORT

Richard gave an overview of the Property Report.

Flooding

We have a price from one of the drainage contractors we approached, it is in within the budget. No timeline for completion, hoping for the work to be done in the school holidays. Noted some potential barriers with the infrastructure - sandpit etc.

Fencing Project

The final stage has been designed and approved. Ferndale is on board with the gate design in the drop off area. This is out for procurement now.

Junior Playground

Discussed. Progress has been made. Marcel asked if there is a design available for circulation. Richard confirmed there is, once the contract is signed, and Gayle (Outdoor Spaces Team) has been bought up to speed with it.

School Property Plan

Sandy and Richard met with the SSL consultant, Tracey, who has been contracted by the MOE to prepare a school property plan for us to review. Environmental data collection equipment has been installed to support the plan. The next step is to meet with SSL and MOE and agree between us what we would like to do.

A funding allocation is being made for us, we have not seen this yet, this is drip fed over the 10 year period. Canterbury kura are the pilot for the new 5Y/P - 10Y/P model.

Funding generally covers; electrical safety, basic maintenance, painting and roofs. With wishlist items being things such as access to komanawa to the field. Until buildings are ten years old, you don't get maintenance \$ for them.
