## 1.0 SPECIAL TOPICS

# 2023 Mathematics Student Achievement Targets - Analysis of Variance

End of year Maths data tabled, Krystal Hunt presented this to the Board.

Krystal noted that Maths end of year data is taken in T3 and compared to the start of year data taken. While no cohorts met the 70% target, all the groups have made progress. The Y5 cohort has made the most progress.

We are in the second year of the Maths programme. Teachers are noticing increased student confidence and engagement in Maths lessons, improved justifying and proving techniques. Teachers are also reporting increased confidence in teaching mathematics.

## Next Steps for 2024:

- The Maths team will continue to take part in termly Professional development led by Rob Proffit-White that will be taken back to teams and changes will be implemented within teams. (Year 3 of the 3 year PD programme)
- There will be a continued focus on Team Leaders working with their teams in the ongoing
  use of data analysis to track student progress and inform teaching and learning.
- Explore the Mathematics curriculum refresh in preparation for the implementation nationwide in 2025.
- Continue with staff development around the e-asTTle tool, and how the data can be used to support maths programmes.

Marcel asked whether the 2025 curriculum refresh will impact on our pedagogical approach? Yes, the good core teaching of mathematics doesn't change regardless of the new curriculum, and with our work with Rob Proffit-White we feel we are setting our children up for success with a solid foundation that means refreshes will likely align well with our approach. Krystal feels we will be on the forefront of the refresh rather than playing catch up.

Richard noted that the data shows that as children go through the years, the spectrum of achievement really gets wider. Richard noted that it must be very hard to teach across the range.

Krystal noted that while a child may never reach the target, we still would like to see one year of growth at least each year.

Attendance also impacts the data and the learning. 80% of attendance for a child in aa year means every five years a child has missed a year of schooling.
