### 7. PRINCIPAL'S REPORTS

The Principal's Report is taken as read.

- A staff only day has been held with the focus of the new curriculum. This was a great day and staff are feeling more confident about the new curriculum.
- The roll has reached the predicted 515 students for 2024. It is estimated that there
  will be 467 students starting 2025. The juniors school's numbers are decreasing as
  the bulge in the cohort moves through the school. The board discussed reasons
  why this has happened.
- The annual plan review is tabled for the board's review. Jo spoke to what had been achieved and what was still left to complete.

# 8. FINANCE REPORT

The Finance Report is taken as read.

Thomas spoke to the accounts. The school is still tracking for a breakeven fiscal year. Expense items that are higher than budgeted are the administration wages, property maintenance and electricity. The board discussed these expenses.

Thomas updated the board on the draft budget for 2025. The predicted deficit is currently \$165,000. Jo and Thomas will do more work on this to bring the budget to an acceptable bottom line. The board discussed various budget line items.

### 9. PROPERTY REPORT

The Property Report is taken as read.

Craig updated the board on a 5YA meeting that had been held with Cameron, the project manager from Logic Group. The Kōmanawa, PTA and Block Eight have been combined into one project. Asbestos has been detected in one of the blocks included in the project This raises no imminent danger to anyone, but will need to be removed correctly. The funding buffer has been applied to this project now to cover the asbestos removal costs. Craig will update the board on the tender process and when the quotes have been received.

Craig also updated the board on the cyclical maintenance. Carus has now been signed up and a quote has been received for the internal painting. The logistics for external work is underway to ensure the external painting is completed over January.
